not be able to attend our Annual Membership Meeting. Or, you can easily vote online by accessing a link that will be sent to you in a separate communication that will arrive via email in October.





## **Celebrating Twenty-Five Years of Women at Work on the National Forest**

From its very earliest days, women volunteers have been front, center and out to the far reaches of the Sedona Friends of the Forest (FOF) organization. As leaders, innovators, or by just plain showing up to get a job done, FOF women have contributed daily to supporting the Red Rock District forest lands, wildlife and visitors.

Mary Lee Dunning set the stage as the founding President of the organization in 1994. She has been followed by many other women as FOF officers, work team or project leaders, and skilled administrative volunteers. On the USDA Forest Service side, women in key positions in the Agency have been supervisors and mentors for FOF volunteers, including some who have worked continuously on the District for twenty-five years.

Through the twenty years for which data is available, Friends women have logged over 150,000 hours of volunteer service, accounting for one of every three hours of FOF work. They are active in all eleven of the Friends work teams, known as Committees, and currently lead three of these teams. Trail Patrol, Visitor Information Services and Cultural Site Docent duty are particularly popular, accounting for almost 70% of this year's women volunteer hours to date. And Friends women can be found working on Trail Maintenance crews, scrubbing graffiti off our red rocks, driving bumpy Forest roads for Air Quality Monitoring or River Ranger Support, and hiking to remote areas for a variety of wildlife and rare plant projects.

Behind the statistics are women like **Justine Kusner, Darl Rector and Jean Ober** who have logged a mere 14,000 hours of service collectively during their years with the Friends. On the occasion of the Friends 20th anniversary, Justine, who served as FOF President in 1999 and 2000, wrote about what attracted her and husband Bill to the Friends: "It was the phrase 'Let's Get Physical'. Less talk, more work. That's our kind of group."

Darl Rector has devoted so much time to patrolling and maintaining our area trails for twenty-four years together with husband Gene, that the Forest Service recently named a trail for the volunteer couple. The Rector Connector is located between Bell Rock and Courthouse Butte. Darl says, "The best thing that happened to Gene and I in retirement was finding and joining FOF. We have made so many wonderful friends and enjoyed a variety of activities. To me, working in the beauty of the red rocks was much like being in

a huge outdoor cathedral. Having a trail named for us has to be the ultimate honor! I am thrilled to still be able to hike and spend time with some great gals on the trails."

Jean Ober is surely a Renaissance FOF volunteer, having brought her talent and energy to nearly every one of the diverse activities of the organization, including serving on the Board and as Newsletter Editor. "The name of our organization "Friends" truly reflects what it is like for me to work with others on the many Committees we have. On trail maintenance, no one is expected to work beyond their capability and I can trim cat claw and branches off the trails, use a McLeod tool to clean drains and reshape trails, plant native cacti to revegetate areas as well as help build rock structures working along-side other ladies and gentlemen of the crew. Comradery and a sense of a job well done are rewards along with the many Friends I have made. These friendships continue to grow as I have expanded to more activities within the organization," Jean says.

The ten busiest women volunteers over the twenty years of recorded data include, **Justine Kusner, Helen Campbell, Darl Rector, Susan Vitek, Lois Johnson, Jean Ober, Sonya Landholm, Marge Larson, Carol Wirkus and Peg Kern**. Collectively, they have contributed 160 years of service to the Red Rock District.

Preparing this story has reinforced my experience of Friends of the Forest as an organization culture where gender is not of consequence. What a delight! In fact, some women I spoke to about the topic of women in the organization expressed surprise that this would be a topic to write about. I have enjoyed this non-topic, nonetheless. My congratulations to the many women volunteering across twenty-five years on the Red Rock District of the National Forest.

And, yes, a few batches of cookies and banana bread have been prepared through the years to sustain those attending FOF quarterly membership meetings.

## Trail Patrol

---

Trail Patrol members continued to hike through the summer. Several of the new Western Gateway trails were covered as well as the rerouted Girdner Trail. The ability of trail patrol members trained to remove graffiti that are scratches on the red rock was favorably commented on by several members. The upgrades to the original smart phone FOF Report app, now called the FOF Graffiti app, to report graffiti, be assigned to remove it, and update the status on the trail really enhances Trail Patrol capabilities. The app also allows members to see if there is reported, but unassigned, graffiti on or near the trail they are going to patrol and elect to perform the removal of it. This function is made much easier with the map of locations of graffiti in the app and using it to navigate to the graffiti location. Thank you, **Bob Haizmann!**

With September 30 rapidly approaching, the end of the government fiscal year, it is critically important that all trail patrollers log their hike as soon as possible after completing it. All volunteer hours for this fiscal year need to be reported

to the Forest Service within the first week of October.

The Trail Patrol committee will continue to schedule one to four group hikes each month. This serves the purpose of training new members to Trail Patrol, helping people to meet new friends, and getting the Trail Patrol co-chairs out on the trails on a regular basis. We always ask those who hike with us which trails they would like to do as a group hike. We also try to include trails that are not as often hiked. So, come and join us.

I would like to extend a special **Thank You** to the docents who have spent time at Palatki, V-Bar-V, and Honanki during June, July, & August. Not only is this the hottest time of the year, we are also chronically short of site hosts over these months and our pool of available docents declines by 1/3. During this 3-month period we had 15 – 22 people per month volunteering an average of 18 – 26 hours per person for a total of 1,142 hours!! This is an increase of 15% over last year and 40% from 2016. Keeping the sites fully staffed and operational is a high priority for the Forest Service. This team has stepped up to meet that challenge and deserves high praise for their dedication and endurance!

The team has been on summer hiatus and will be resuming activities in October.

#### **Cultural Site Photo Documentation Project**

The site photography project still has several years of work ahead. The current list of ongoing projects includes re-photographing major prehistoric sites using conventional, RTI, and 3-D technologies, similar photography for newly recorded sites, and periodic monitoring of the dust study images at Palatki and Honanki. The team has also been busy creating 3-D images of selected historical Forest Service structures in the Red Rock and Peaks districts. Activities have slowed down considerably over the summer months due to the heat. The team was able to complete 3-D modeling projects for historic structures at Crescent Moon Ranch and a project with the National Park Service (Montezuma Castle NM) to model a modern reconstruction of 4<sup>th</sup> level room.

This team has been in operation for a little more than 6 years and completed their first 3-D model in June of 2016. In that time, they have visited and photographed over 500 sites (over 100 were “new” sites to the Forest Service) and taken over 100,000 photos! They have also created over 1,600 3-D models that have had over 26,000 views on the Sketchfab hosting site (<https://sketchfab.com/FOFSedona>).

The team has recently taken on an ASU Archaeology undergraduate student **April Heinrich** to help the Friends with the Dust Study project and assist April to gain credits towards her degree.

**Governor’s Award for Avocational Archaeology** – Spence Gustav received this prestigious award on behalf of the entire team at a statewide meeting held in Prescott. The award was for their leading-edge work in 3-D modeling and the Dust Study. They are learning that the Dust Study work has crossed over into the bleeding-edge arena. Spence also participated in a panel discussion on these topics. Kudos to this small, fanatical, and talented team on their accomplishments!

Welcome back summer travelers!

Since our last Board meeting, it seems like we've been preoccupied with the removal of PAINT!

Of course, by numbers of reports, the vast majority of graffiti is still scratching on the rocks. This kind of damage is being continually remediated by approximately 40 of our team members. The most active (30 or more hours in the field since April) are **Jerry Checchia, Tim Fogarty, Annie Glickstein, Bob Haizmann, Bill and Bea Logan, Les and Barb Heffner, and Pete Malmgren**. A special note of appreciation for their outstanding efforts. In addition, we have welcomed even more new members who have completed their software and field training and are now joining our group on outings. A very warm welcome to **Mike Donahue, Rod Cashin, and Jeff Harvey**.

We've kept everyone busy at the usual problem sites – Bell Rock, Slide Rock, West Fork, Fay Arch, and Devil's Bridge. These are in addition to the less frequented locations where a single team member can remove scratching.

Paint, however, is still our most challenging problem. The removal process is made even more frustrating, I guess, because it is so much easier to carry a couple of cans of spray paint into the forest and wilderness than it is for us to lug the gallons of water, "Snot", wire brushes, high pressure washer, and miscellaneous supplies (Does the term Sherpa sound


familiar)? Areas which we have cleaned are HT Trail, Little Horse trailhead restrooms, Munds Wagon, Huckaby Trail (exact same rock TWICE in two weeks), Slide Rock, and 89A at the switchbacks.

In addition, I am excited to report that our team has been requested by the Forest Service Flagstaff District to assist their Rangers in naturalizing a very serious paint situation. They do not have a similar volunteer force to assist them with the removal and our Red Rock Graffiti Removal team is more than glad to be of assistance. We've met with their Recreation Manager, Mr. Pat McGervey and his Volunteer Coordinator, Mr. Paul Dawson to review our graffiti remediation methods, learn about their methods, and share ideas for future cooperative efforts. Shortly after this report is submitted, on Thursday, 9/5/2019, we will be taking a large graffiti team to Flagstaff and will spend the morning working with their staff removing as much paint as time allows. Attached to this article are several photos from our first visit.

It's obvious that summer was not a vacation time for us. However, all 78 of our members take great pride and satisfaction in knowing we really are making a difference in the forest.





## Wildlife/Fish/Rare Plant Projects

**Arizona Toad Inventory Year 2:** In the spring of 2019, 20 trained volunteers assisted district biologist, Janie Agyagos, in conducting a second year of surveys for Arizona toads on the Red Rock Ranger District; none were found. These surveys provide support for listing the Arizona toad as an endangered species by the U.S. Fish and Wildlife Service. Three methodologies were used: nighttime call point surveys at accessible sites, daytime visual surveys at less accessible sites, and acoustic recordings in very remote headwaters. Five species of amphibians were detected: canyon treefrog, the non-native Pacific treefrog, Woodhouse toad, red-spotted toad, and lowland leopard frog. All nighttime survey data was entered into an ArcGIS app created by volunteer **Rob Gibbs**. In addition to night call point surveys, visual surveys revealed canyon treefrogs. A third sampling technique, used for the first time in 2019, was the deployment of recorders at 14 head water locations, mostly in wilderness areas. Recorder data is still being analyzed by volunteers using Raven Pro sound analysis software from the Cornell Lab of Ornithology. So far volunteers have analyzed 5,614 hours of data and have confirmed recordings of canyon treefrog and many bird species, a few of which were unexpected. According to volunteer **Annie Glickstein**, "Although the main target of this study was Arizona Toads, Raven provided the opportunity to make a small collection of bird calls that were identified by some of the FOF birders". Her most unusual bird call detected is the Northern Saw-whet Owl, "because it sounds like a squeaky gate".

**The Search Continues: Verde Valley Domesticate Agave Inventory...** FOF volunteers are participating in a project to find and document agave varieties cultivated by the pre-Columbian people. These domesticated agaves were used for food, medicine, cordage, textiles, and building materials. Botanists have identified 4 types of domesticated agaves in the Verde Valley with 2 of those endemic to the Verde Valley. Domesticated agaves are most likely found near archaeological sites. The attached map shows areas assigned to volunteers to search, with red indicating in progress, blue complete. Search techniques include hiking, glassing (binoculars), and driving on remote Forest Service roads. There are many areas left to search - a training session will be held when cooler hiking weather returns. ## Volunteer Hours
