Statistical Summary

Volunteer Hours

The Friends have volunteered an amazing 20,533 hours in the 1st half of fiscal 2018; that's an average of over 3,420 hours per month, or about 790 hours per week! This represents an 8% increase over the same period last year, so we're continuing on our path to another new record for the year.

Cultural Resources continues on a staggering pace, already surpassing the full year total for 17 of the past 19 years. Also, Special Projects included 1,648 hours in support of Wildlife Projects (aka 'Janie's Projects'); for the same period last year, 320 hours were reported for this category, so that's an increase of 415 percent!

Site Recording Project

The team has concluded activities until the fall. The team was able to record and document 19 sites and analyze 1,500 sherds and lithics. There are still enough currently known unrecorded sites for this project to continue for several more years.

Cultural Site Photo Documentation Project

This team photographically records archaeological sites and artifacts utilizing numerous techniques. These techniques include conventional digital photography, 3-D modeling, RTI (Reflectance Transformation Imaging), and image enhancement using specialized software. Both the 3-D modeling and RTI processes require a firm protocol and attention to detail to achieve even mediocre results.

This team has remained quite active and has been focused on sites that are more difficult to access. This team is a hardy bunch and will remain active over the summer.

The Pictograph Degradation Analysis project, that was describe in the last newsletter, is officially underway. Reproduction pictographs using several traditional pigments and several binders were created on small sandstone slabs. These slabs are being placed in select locations at

Palatki and Honanki. A control set is being kept indoors. Baseline photos have been precisely calibrated and new photos will be taken periodically for comparison. This will be a long running project. Small signs will be placed near the slabs describing the project. Because the study requires precise calibration and repeatable measurements, the slabs should not be touched, picked up, or moved. Many thanks to *Nori Thorne* for creating the authentic reproduction pictographs and an excellent video of the process!

First and foremost, a big thank you to all of our wonderful volunteers, and welcome **Karen Hazzard**, the latest volunteer to complete training.


Despite the worst flu season in memory, visitors kept coming, and we continued to welcome them. Our volunteers were on hand to greet the nearly 80,000 visitors that passed through our doors in the 1st quarter of 2018. Visitation in Q1 outpaced Q1 of 2017 by 4.3%,and shows no signs of slowing down. Extra shifts were added in March, April and May to help accommodate the steady stream of visitors.

Obviously, parking at the trailheads continues to be a challenge. In fact, some visitors have returned to the Visitor Center to voice their frustration at the inability to find a place to park.
